<u>CAMPAIGN 5268</u> – RECALL CAMPAIGN All Fiat GRANDE PUNTO models - rear axle

On the 17 Fiat Grande Punto vehicles of all models, whose chassis numbers are enclosed (ann.1) a workshop operation has been defined to check that the rear axle stands are correctly attached to the bodyshell.

The operation must be carried out before delivering the car for vehicles in stock. Customers must be contacted using the registered mail letter (annex 2) if cars are already handed over, in accordance with the procedure recorded in the annex (ann. 3) to ensure the entire fleet is updated.

We are also sending you instructions for the procedure to be followed for practical implementation of the operation by Dealers (see appendix 4).

FAULT: Non-compliant fixture

RECALL CAMPAIGN

FAULT TO BE PREVENTED:

Rear noise and in a small number of cases ruptured stands

TECHNICAL CAUSE:

Non-compliant tightening and/or missing bolts at the front of the rear axle stands.

OPERATIONS IN PRODUCTION:

Guaranteed compliant fitting.

OPERATING PROCEDURE

PREVENTIVE ACTION:

Check if front bolts on the rear axle stand are present.


If even on a single stand a bolt is found to be missing, the vehicle is non-compliant and you must proceed with the replacement of the stand concerned and the subsequent tightening to torque of the screws on both stands.

OPERATING PROCEDURE

Working on the lower rear end of the vehicle check if the front screws for the rear axle stands are present.

- If present the vehicle is compliant.
- Check that the screws fixing the stands to the bodyshell are tightened to 8 daNm.
 - If even on a single stand a screw is found to be missing, the vehicle is non-compliant and you must proceed as follows:
- Replace the stand without the screw with the part No. 55703447 (left) and/or part No. 55703448 (right) as described in the Workshop Manual operation 4420 D 30, taking care when fitting screw / nut part No. 55701512 / part No. 811900442 securing the stand to the axle (13 daNm) and subsequently screws part No. 55701536 securing the stand to the bodyshell (8 daNm)

NOTE: Follow the correct procedure for tightening bolts / nuts securing the rear axle stands to avoid damaging the elastic bushes.



- Bleed the brakes.
- Adjust the wheel geometry.

a) Overall vehicle pool affected by the operation

The campaign affects all vehicles with chassis numbers entered in SIGI upon campaign activation

b) <u>Identification of affected vehicles</u>

- vehicles allocated to you refer to the file containing chassis numbers subject to the campaign present in your PC
- vehicles in transit Before carrying out the operation check :
 - 1) with a SIGI inquiry to see if the chassis is subject to the campaign;
 - 2) for the presence of any identification marks to confirm that the campaign has already been carried out
